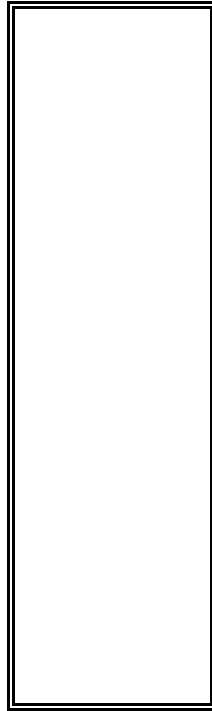

**VST ENTRY FEE: \$125.00.** A \$.50 AKC Recording Fee plus \$3.00 AKC Event Service Fee are included in each entry and will be forwarded to the AKC per Chapter 11, Section 2.

**ENTRY LIMIT:** Entry is limited to three (3) dogs who have earned an AKC tracking title (TD, TDU, TDX or VST). Priority will be given to dogs that have not yet earned a VST title. Judges will determine if an alternate track will be laid.

**CLOSING DATE: 5:00 PM on Wednesday, December 20, 2017,** after which time entries cannot be accepted, cancelled, or changed.

**MAIL ENTRIES WITH FEES TO:** Lizanne Kaiser, Tracking Test Secretary, 5858 Ralston Ave, Richmond, CA 94805. Make checks payable to ODTC.

**PLEASE DO NOT REQUIRE A SIGNATURE FOR MAIL DELIVERY.** Entries which require a signature for delivery are unlikely to be received. Please indicate "NO SIGNATURE REQUIRED" if using express mail services. No fax, online, or credit card entries.

**DRAWING FOR ENTRIES:** A random drawing of entries and alternates will be held on Wednesday, December 20, 2017, at 6:30 PM, at the Oakland Dog Training Club Training Hall, 5327 Jacuzzi Street, Richmond, CA 94804. When the limit of three (3) dogs for the VST test is reached, the drawing will continue for alternates in the test.

**NOTIFICATION:** Notification of the results of the draw will be made as soon as possible by email to exhibitors, if an email address is provided on the entry form. Alternates have the right to withdraw their entry and decline to be placed on the alternate list. The judging program with entry confirmation shall be sent by both email and by US Postal mail as soon as possible.

**REFUND POLICY:** The entry fee shall be refunded in the following cases: (1) If the entrant notifies the Test Secretary at least 48 hours prior to the test, and an alternate is available to run the track; or (2) for an entrant or alternate that is not given an opportunity to run a track.

**BITCHES IN SEASON MAY PARTICIPATE** in this test with prior notice to the Test Secretary and compliance with all provisions of Chapter 2, Section 8 of the AKC Tracking Regulations.

**THE HEALTH AND SAFETY** of the dogs, exhibitors, judges, and spectators is of paramount importance. The test may be cancelled or stopped before completion in the case of extreme weather conditions such as, but not limited to, lightning, extreme heat, hurricanes, floods, or earthquakes, for the well-being of people and dogs.

**RUN ORDER:** A drawing for VST track running order will be held at the test site at 9:15 AM. Entrants not present at the time of the draw will be marked absent and an alternate will be allowed to run in their place. Judging will begin when tracks have aged sufficiently.

**PRIZES:** A ribbon will be awarded to any dog passing its VST track. A 'photo plaque' will be mailed to the passing entrants after the event.

**LUNCHEON** will be provided for exhibitors and spectators after the test.

**DIRECTIONS TO TEST SITE: CALIFORNIA STATE UNIVERSITY EAST BAY,** 25800 Carlos Bee Blvd, Hayward, California 94542. **From Oakland Area,** Take Highway 580 Eastbound to Hayward and exit on the Hayward exit. Continue on Foothill Blvd into downtown Hayward. Turn right onto "A" Street, two blocks, left onto Mission Blvd for several blocks. Turn left onto Carlos Bee Blvd, go up hill, and stay to the far right to enter the campus. At stop sign, turn left, go one block, turn right and park in Parking Lot "L" behind Music-Business Building.

**Parking:** Please follow all campus parking rules and possible fees. The campus typically does not charge for parking on the weekends.

**PLEASE DO NOT PRACTICE AT THE TEST SITE  
WITHIN THREE DAYS OF THE TEST, per AKC regulations.**

**CSUEB HAYWARD CAMPUS:** Please keep your dogs on leash at all times and pick up after your dogs. Upon arrival at the site, please check with the Test Secretary for the location of the designated dog potty area and directions to restrooms. All attendees are responsible for cleaning up after their dogs.

### AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss of or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. ### INSTRUCTIONS

- (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in, over 13 in, but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries close after the date acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter 11, Section 3).
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
