

DIRECTIONS TO TEST SITE: California State University East Bay (CSUEB), 25800 Carlos Bee Blvd, Hayward, CA 94542. From Oakland Area: Take Highway 580 Eastbound to Hayward and exit on the Hayward exit. Continue on Foothill Blvd into downtown Hayward. Turn right onto A Street, go two blocks, then left onto Mission Blvd for several blocks. Turn left onto Carlos Bee Blvd, go up hill, and stay to the right to enter the campus. At stop sign, turn left, go one block, turn right and park in **Parking Lot L** behind the Music-Business Building.

CSUEB HAYWARD CAMPUS: Per AKC regulations, do not practice at the test site within three (3) days of the test. Attendees are responsible for their dogs. VST ENTRY FEE: \$125.00. AKC Recording (\$0.50) and Event Service (\$3.00) Fees are included in each entry and sent to AKC per *AKC Rules Applying to Dog Shows*, Chapter 11, Section 2.

CLOSING DATE: Wednesday, December 19, 2018, 5:00 PM Pacific, after which time entries cannot be accepted, cancelled, or changed.

ENTRY LIMIT: Entry is limited to three (3) dogs who have earned an AKC tracking title (TD, TDU, TDX, or VST). Priority will be given to dogs that have not yet earned a VST title. Judges will determine if an alternate track will be laid.

DRAW FOR ENTRIES: Draw of entries and alternates will be held on Wednesday, December 19, 2018, at 6:30 PM, at Oakland Dog Training Club, 5327 Jacuzzi St, Richmond, CA 94804. When the limit of three (3) dogs is reached, the drawing will continue for alternates in the test.

NOTIFICATION: Notification of the draw results will be made as soon as possible by email to exhibitors, if an email address is provided on the entry form. Alternates have the right to withdraw their entry and decline to be placed on the alternate list. The judging program with entry confirmation will be sent by both email and U.S. Postal mail as soon as possible. BITCHES IN SEASON: May participate in this test with prior notice to the Test Secretary and in compliance with all provisions of *AKC Tracking Regulations*, Chapter 2, Section 8.

HEALTH AND SAFETY: Of the dogs, exhibitors, judges, and spectators is of paramount importance. The test may be cancelled or stopped before completion in the case of extreme weather conditions or emergencies such as, but not limited to, lightning, extreme heat, hurricanes, floods, fires, or earthquakes, for the well-being of people and dogs.

RUN ORDER: Track running order will be drawn at the test site on Sunday, December 30, 2018 at **9:15 AM**. Entrants not present at the time of the draw will be marked absent, and an alternate will be allowed to run in their place. Judging will begin when tracks have aged sufficiently.

REFUND POLICY: Entry fee shall be refunded: (1) If the entrant notifies the Test Secretary in writing **prior to the draw for running order** AND an alternate is available to run the track; or (2) for an entrant or alternate that is not given an opportunity to run a track.

ROSETTE: Will be awarded to any successful participant passing a VST track.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
